## ELIGIBLE CRITERIA AND RESPONSIBILITIES FOR "AAMAR DUKAN ON WHEELS" HOLDERS

### **(A) The Eligible Criteria for selection of candidates.**

- (1) A selection committee constituted for the purpose will select 6 nos. of beneficiaries for the District of Tinsukia.
- (2) The selected beneficiary should be citizen of India and a permanent resident of Assam.
- (3) The applicant should be unemployed youth minimum HSLC or equivalent qualification.
- (4) The applicant should have no other source of income.
- (5) The applicant should be of minimum 18 years of age on the date of application.
- (6) The applicant will have to distribute 23 nos. of Essential Commodities to the consumers through E-Rickshaw over and above some other commodities.
- (7) The applicant after selection will have to obtain Trade Licence from the concerned Authority for running the "AAMAR DUKAN ON WHEELS".
- (8) The beneficiaries shall register of E-Rickshaw under Assam E-Rickshaw Rules, 2017 and obtain driving licence from the concerned DTO as per the Rules.
- (9) The beneficiary shall have to submit Income Certificate to present his ability to bear the expenses of his own contribution.
- (10) The E-Rickshaw will be insured for First party by the beneficiary.
- (11) The selected beneficiary will execute an Agreement with the Deputy Commissioner before release of grant-in-aid.
- (12) The Deputy Commissioner will fix the route / area of operation through which the "AAMAR DUKAN ON WHEELS" will operate.

### **(B) Responsibilities of the beneficiaries**

- (1) The beneficiaries will keep the commodities allotted by the Deptt. in case of "AAMAR DUKAN ON WHEELS" in addition to other commodities.
- (2) The selected beneficiary will be allowed to take a profit margin of Rs. 2.00 to 3.00 per kg. / per ltr. from consumers must below the M.R.P. based on the landing cost and minimum profit including Transportation.
- (3) The selected beneficiary must abide by the directions issued by Director, FCS&CA, Assam, Guwahati and Deputy Commissioner, Tinsukia. Any lapse on the part of beneficiary will be viewed seriously and legal action will be initiated and also he will have to return the financial Aid alongwith interest to the Authority.
- (4) The beneficiary should operate his shop as per the time schedule specified by the Authority. Any lapses in this regard will amount to the cancellation of his licence.
- (5) The "AAMAR DUKAN ON WHEELS" must compulsorily displayed prices of Essential Commodities while distributing commodities.
- (6) The "AAMAR DUKAN ON WHEELS" holders will lift commodities from the selected Wholesalers/Stockist as per direction of the Deputy Commissioner.
- (7) The "AAMAR DUKAN ON WHEELS" will not refuse to lift commodities from the selected Wholesalers / Stockist.
- (8) The "AAMAR DUKAN ON WHEELS" holders should maintain stock book and distribution register for inspecting Authority.
- (9) The beneficiary will operate the "AAMAR DUKAN ON WHEELS" himself. He shall not allow any other person to operator / run the "AAMAR DUKAN ON WHEELS" under any circumstances. There shall be no scope for letting out the "AAMAR DUKAN ON WHEELS" to any other person.
